

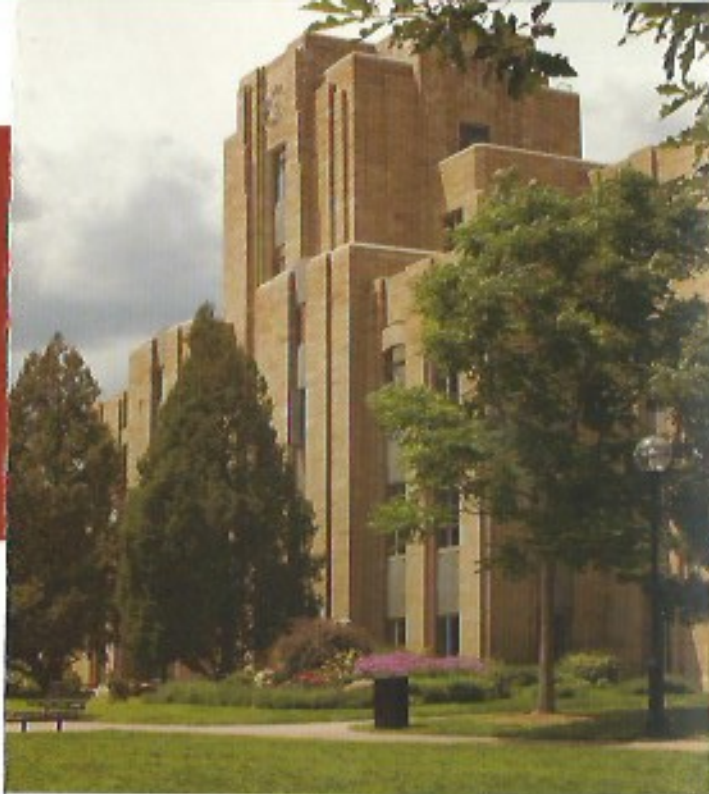

- Reports of justices, appellate judges & district court judges are available at the Secretary of State's Office.

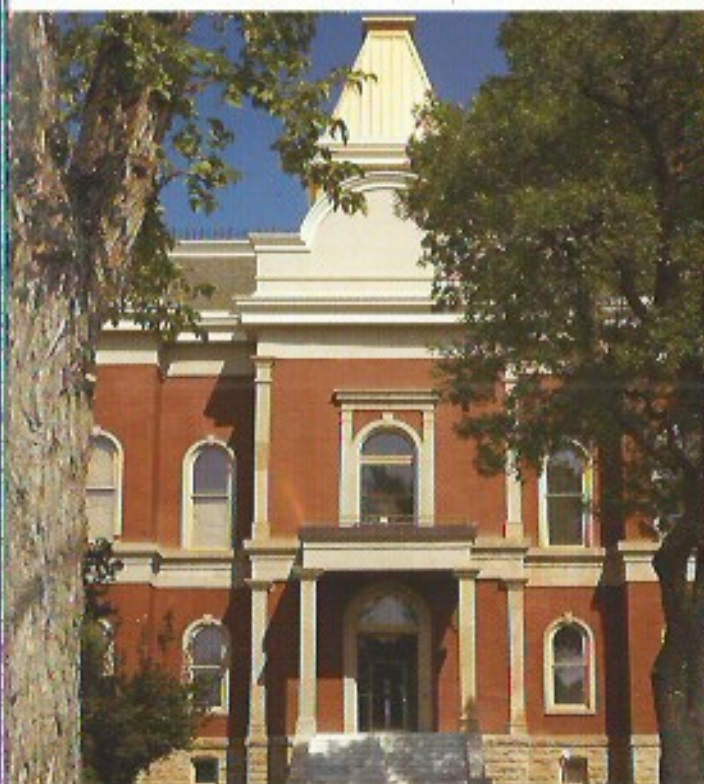
