I. Numbers for 2021:

Current Pro Bono Panel Numbers and Case Trends:

- **131** individual lawyers, **41** Law Firms/Organizations.

Number of **Orders of Appointment** entered by judicial officers in 2021 was **38** entered, one of which has an additional **31** member cases as part of a consolidation of cases of Judge Kane’s concerning Denver Jail Covid-19 conditions – those cases have been taken by group of lawyers. A total of **69** orders of appointment have been entered to date.

- The Panel program made **22 appointments (44 entries of appearance)** independently of the JLK consolidated case, **9** of which were Federal Limited Appearance Program (“FLAP”) appointments through the CBA Young Lawyers Division. Overall success rate: **78%**; success rate not counting the JLK consolidated cases: **32%**; not counting FLAP cases, **19%**.
